Looking Ahead to New Opportunities

Tackling Current Challenges

Last year, the Dare Education Foundation experienced the successful culmination of a number of years of hard work and steadfast dedication for two of our initiatives - specifically, Passport to Higher Education (Passport) and Affordable Teacher Housing.

As a part of Passport, the AVID (Advancement Via Individual Determination) program saw its first graduating class in June 2011 from Manteo High School. Even more exciting is that **all of those students have gone on to post-secondary institutions** and **most of them received scholarships** in order to be able to pursue a degree. Further, many of them will be the first in their families to attend college, and incredibly, **they are students that might otherwise have fallen through the cracks** as simply average performers. Also, thanks to a confluence of favorable conditions, this year saw the opening of our newest affordable teacher housing complex serving Hatteras Island with 12 units in Buxton. These apartments have already proven to be a powerful recruitment and retention tool for Dare County Schools in Kill Devil Hills. Now we are anxious to see what positive outcomes will result for our students in Hatteras. We expect to see increased competition among the applicant pool and less teacher turnover.

This year also witnessed change within DEF. There is a new Executive Director, Elisabeth Piff, and a new Chairman of the Board, William Pfeifer. Together we are looking forward to strengthening our existing programs, as well as setting new goals for our organization, to see that the children of Dare County continue to receive the best-quality education possible.

And, even though we are experiencing the same financial challenges being felt worldwide, we are pleased to say that as a result of the generous support of **this** community, we are able to continue helping our teachers with their professional development, assist the school system with maintaining some flexibility, and bring innovative programs to our students that would not be possible in our area through Dare County Schools alone. **Our programs are more critical than ever** given the current fiscal environment, and we are proud that we can provide assistance that beneficially impacts **every** school, **every** teacher and **every** student in Dare County. **To all of our donors, we wholeheartedly thank you!** Together we touch the future, and we **CAN** make a difference in ensuring the best possible foundation for these children and their lives to come!

Excellence In

The Dare Education Foundation (DEF) works in partnership with our community and Dare County Schools to promote excellence in education. DEF's dream is the best education possible for every student in every school in Dare County.

Passport to Higher Education

DEF's Passport to Higher Education Initiative is creating a career/college-ready culture for all students and closing the achievement gap for students in the academic middle. DEF funds, totaling over \$250,000 by the end of this school year, support the AVID program at every secondary school in the district. Nearly 250 students were enrolled in AVID district-wide in 2010. Often, these students are from low-income or minority families and they may be the first generation to have the opportunity to attend college. Students attend an AVID class daily where they learn note-taking and study skills, get tutor support and participate in goal-setting activities. AVID students also have an opportunity to work with community mentors and experience college tours. Nationally, 95% of AVID graduates go on to college and 75% earn a four-year degree. What's more, the entire student body benefits from enhanced school-wide instructional strategies. Our first AVID graduating class is pictured on the right.

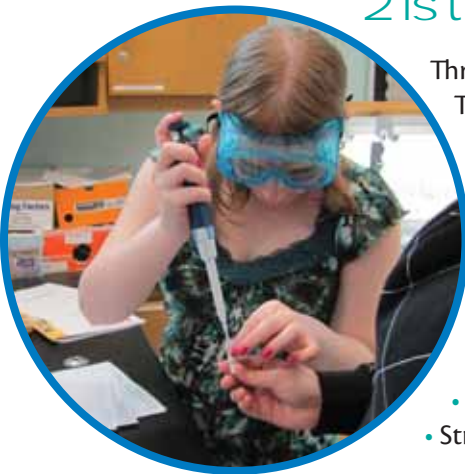


21st Century Skills

Through DEF's 21st Century Skills Initiative, DEF has awarded 73 grants, totaling over \$102,000. These innovative projects, such as the CHSS Biotechnology Labs and Fingerprinting Grant (pictured at left), are funded by DEF and are helping teachers make learning more relevant, while encouraging critical thinking, creativity and collaboration among students.

Teacher Academy

The impact of DEF's investment on student success is remarkable. National Board Certification requires teachers to take an in-depth look at their teaching, refine their classroom strategies, practice new techniques, and prove themselves to be masters at the art of developing young minds. It was announced in the Fall of 2011, that in the last 11 years, the number of Dare County Schools' teachers who have earned their National Board Certification has grown from 4 to 100. Currently, North Carolina leads the nation in Nationally Board Certified Teachers at 19% of total teachers. Dare County **surpasses** that at 26%.



Run Hill Ridge and Hatteras Teacher Housing

Our affordable teacher housing complexes, Run Hill Ridge and Hatteras Teacher Housing, are helping enable Dare County Schools (DCS) to hire and keep highly qualified teachers in our classrooms.

Twenty-two new teacher recruits from other districts or states have been tenants of Run Hill Ridge over the past three years. And, in our newly completed Hatteras Housing, there are currently seven teachers with most being new recruits from other states or districts. These teachers depended upon these housing initiatives in order to be able to move to Dare County and accept the position being offered them.

The housing has also assisted DCS in recruiting teachers for positions that are desperately needed, yet are more difficult to fill, such as foreign languages, advanced math, technology and special needs. In fact, the apartments have helped DCS build a foreign language program, particularly the elementary Spanish and ESL components, by providing affordable housing for these teachers.

Further, the complexes have provided an opportunity for graduates of DCS to be able to move back to the area and afford to live here independently. These tenants, who are already heavily invested in our community and our schools, have said that they either would not have been able to afford to return to Dare County to teach at all, or they would have had to continue living with their parents in order to have been able to do so.

New Common Core Standards & Project Based Learning – What’s DEF got to do with it?



In June of 2010, the State of North Carolina adopted new “Common Core State Standards” for grades K through 12 in math and language arts, an initiative spearheaded by the National Governors Association Center for Best Practices and the Council of Chief State School Officers.

Concurrently, North Carolina’s Department of Public Instruction developed a new set of “Essential Standards” which, like the Common Core did for math and English, added more rigorous content and new teaching approaches for all of the remaining subject areas.

One benefit of the Common Core not only being implemented statewide in NC, but having also been ratified by 46 other states and the District of Columbia, is that these standards represent an opportunity for clarity and consistency across states in what is taught and tested in public schools.

Another strength of having a Common Core comprised of research- and evidence-based standards that were created by a consortium, is that it allowed them to be built upon the identified strengths, as well as lessons learned, from all of the former state standards, rather than what “worked” or “failed” in just one or two states. Further, in addition to being based on best practices in the US, strategies and skills from other top-performing countries were incorporated as well, ensuring that our graduates will be capable of meaningfully participating as a part of a global economy and a global society.

Dare County Schools’ teachers began instructing based on some of the new standards this Fall and students will be

tested on them for the first time next school year, in the Spring of 2013.

Although both the Common Core and Essential Standards have required a shift in **what** is taught, more importantly, they have and will continue to require a rather dramatic paradigm shift in **how** it is taught. Students will be much more consistently engaged in working on real-life problems by practical, hands-on application of the skills they are learning. This is what will be required of them to be successful in college, in professional circles, and in life, and these standards will help make sure that our graduates are ready.

You may be surprised to learn this, but DEF, through private donors like YOU, has been championing these sorts of advancements for a number of years in Dare County. For example, some of the teaching strategies employed by the AVID teachers are what is now being mandatorily implemented in every classroom across the state.

Further, our 21st Century Skills Grants program has been able to act as an incubator for innovative, project-based learning ideas which stress collaboration, communication, extrapolating the knowledge students already possess across subjects and resourcefulness in the way that pupils go about finding answers when the reference sources may not be immediately obvious to them.
